STATE OF CALIFORNIA

CALIFORNIA OCEAN SALMON PERMIT HOLDERS

- CRITERIA**
- MUST have purchased a 2007 Salmon License, Stamp or Permit
 - Covers the period of Salmon landings March 15 - October 31, 2002-2007.

MINIMUM PAYMENT

- No salmon landing in 2005, 2006 or 2007 payment will be \$2,000
- With a salmon landing in 2005, 2006 or 2007 – minimum payment is \$5,000 or catch payment, whichever is greater, not to exceed the cap.
- If a person owns more than one permit, or if they have permits in multiple states, they will receive the minimum payment for each permit. If a person has a 2007 permit and has a personal catch history on another permit that they owned in a previous year, they can claim their previous personal catch. If, however, that catch history is sold as part of a contract of purchase of a permit, we will honor that contract. One person will not be allowed to claim another person's catch, unless it is included in a valid contract of sale.
- No two individuals can claim the same catch history.
- If a person has landings in more than one state, they MUST claim the same year in each state.

BEST YEAR PAYMENT for those with landings in 2005, 2006, or 2007

- Select Best Year of Salmon Landings - 2002-2007
- Pounds multiplied by \$3.00/lb
- Minimum payment **OR** catch payment, whichever is greater not to exceed the cap.
- \$225,000.00 cap,

CALIFORNIA OCEAN SALMON COMMERCIAL PASSENGER FISHING VESSEL/CHARTERBOATS

- CRITERIA**
- MUST have purchased a 2007 Salmon Guide License and must have at least one documented paying salmon angler passenger 2002-2007.
 - Covers the period of Salmon landings February 1 - November 30, 2002-2007

- MINIMUM PAYMENT:**
- Documented paying salmon angler passenger 2002-2004, not in 2005-2007, you will receive payment of \$2,000.
 - Document paying salmon angler passenger 2005, 2006, or 2007, you will receive \$5,000 or salmon angler passenger payment whichever is greater, not to exceed the cap.

BEST YEAR PAYMENT for those with salmon passengers 2005, 2006, or 2007

- Select Best Year 2002-2007
- Charterboats - \$85.00 per paying salmon angler passenger of best year.
- Minimum payment OR salmon angler passenger payment, whichever is greater, not to exceed the cap.
- \$225,000.00 cap.

CALIFORNIA SALMON PROCESSORS/WHOLESALERS/DEALERS

- CRITERIA**
- Must have purchased a 2007 Processor/Wholesaler/Dealer License
 - Cover the period of Salmon landings - March 15 - October 31, 2002-2007
 - Must have purchased a salmon in 2005, 2006 or 2007

- MINIMUM PAYMENT**
- \$500.00

BEST YEAR PAYMENT for those who purchased salmon in 2005, 2006 or 2007

- Select Best Year 2002 - 2007 multiply by \$.65 per pound
- Minimum payment OR Salmon poundage purchased, whichever is greater, not to exceed the cap.
- \$225,000.00 cap

CALIFORNIA OCEAN CHINOOK SALMON-RELATED BUSINESSES

CRITERIA

- Must have purchased a 2007 Business License
- 30% of the business MUST be documented as salmon related
- Select year of best salmon related business between 2005 - 2007.
 1. Submit copies of Tax Return and Schedule C for that designated best year.
 2. Provide a 2008 Profit and Loss Statement.
- 50% of documented loss up to the cap will be paid upon receipt of application and required documentation. The remaining amount, (unless the cap has been reached) will be paid after all applications have been received and the total amount of business requests for disaster relief have been calculated. Total amount paid will not exceed cap.
- \$225,000.00 cap.

SACRAMENTO, CALIFORNIA IN-RIVER GUIDES

CRITERIA

- Must have purchased a 2007 Salmon Guide License and must have at least one documented paying salmon angler passenger 2002-2007.
- Does NOT have a Coast Guard Inspection Certification for carrying more than 6 passengers.
- Covers the period of Salmon landings July 16 - December 31, 2002-2007

MINIMUM PAYMENT

- Documented paying salmon angler passenger 2002-2004, not in 2005 - 2007, you will receive payment of \$2,000.
- Documented paying salmon angler passenger 2005, 2006, or 2007 you will receive \$5,000, or salmon angler passenger payment whichever is greater, not to exceed the cap.

BEST YEAR PAYMENT for those with salmon passengers in 2005, 2006 or 2007

- Select Best Year 2002-2007
- Guides \$175.00 per documented paying salmon angler passenger of Best Year
- Minimum payment **OR** Salmon Angler Passenger payment, whichever is greater, not to exceed cap.
- \$225,000.00 cap.

SACRAMENTO IN RIVER SALMON- RELATED BUSINESS

CRITERIA

- Must have purchased a 2007 Business License
- 30% of the business **MUST** be documented as salmon related
- Select year of best salmon related business between 2005 - 2007.
 1. Submit copies of Tax Return and Schedule C for that designated best year.
 2. Provide a 2008 Profit and Loss Statement.

PAYMENT

- 50% of documented loss up to the cap will be paid upon receipt of application and required documentation. The remaining amount, (unless the cap has been reached) will be paid after all applications have been received and the total amount of business requests for disaster relief have been calculated. Total amount paid will not exceed cap.
- \$225,000.00 cap
